DATA PROTECTION GUIDELINES OF THE PRESS FREEDOM FOUNDATION'S MEDIA OUTLETS

Szabad Magyar Szó complies with the data protection (GDPR) rules of the European Union valid from May 25, 2018

Who we are

Our website address is: https://www.szabadmagyarszo.com and https://www.szmsz.press. Szabad Magyar Szó is a public forum of the Press Freedom Foundation.

What personal data we store and for what purpose

Comments

Our posts only offer the opportunity to comment in exceptional cases. When submitting a comment, the commenter's IP address and browser identification string are automatically collected in addition to those specified in the comment form to filter out unsolicited content.

A depersonalized character string (hash) generated from the email address is transmitted to the Gravatar service if it is in use. The terms of Gravatar can be viewed at https://automattic.com/privacy/. After the comment is accepted, the content of the comment and the affiliated profile picture will also be publicly displayed.

Media

If the registered user uploads a picture, EXIF metainformation that includes GPS position data should be avoided. Website visitors can download these and extract location data from the images on the website.

Cookies

After writing a comment, the website stores the entered name, email, and web address in a cookie. The storage is only for convenience purposes, so that it does not have to be filled in automatically the next time you post. The expiration date of cookies is 1 year.

If you have a user account and are logged in to this website, we set temporary cookies to determine whether the browser accepts cookies. These cookies do not contain personal information and are deleted as soon as you close the browser.

When logging in to the website, we create several cookies that save the login information. Login cookies are valid for two days. If the "Remember me" option is selected, the registration will continue for two weeks. Login cookies are removed when you log out.

Embedded content from other websites

Posts available on the website may use embedded content from external sources (e.g., videos, images, articles, etc.). Embedded content from an external source behaves exactly as if you had visited another website.

These external websites potentially collect data about visitors, use cookies or third-party tracking code, monitor user behavior related to embedded content if you have a user account and are logged in to the site. These external circumstances are not under the control of Szabad Magyar Szó, it is up to the user to become familiar with them.

With whom we share user data

Szabad Magyar Szó never shares user data with third parties.

How long we keep personal data

If you comment on a post, the comment and its metadata remain in the system for an unspecified period. The purpose of this is that all subsequent comments become known and approved by us, i.e., they do not appear on the list of comments to be moderated.

The personal data of users registered on the website (if any) are also stored in their user profile. All users can view, edit, or delete their personal data at any time (except they cannot change their own username). Website administrators can also view and edit this information.

What rights users have regarding their own data

In connection with the account or comment registered on the website, it is possible to request the sending of personal data in an export file (to the primary email address of the data provider), which contains any data previously provided by the user. You can request that we delete any previously provided personal data, except for the data that we are obliged to keep for administrative, legal, or security reasons,

Where we transfer the data

Comments submitted by visitors can be checked by an automatic spam filtering service.

EUROPEAN PODCAST ACADEMY (EPA) APPLICANT DATA RULES

Data types: Surname and given name, date of birth, tax ID; Disability Certificate upon request

Purpose of the processing: European Podcast Academy application management

Legal bases: Processing of data requested for pre-contractual evaluation based on GDPR 6(b)

Is it mandatory to provide date? Yes: general data; No: confidential information

Legal or contractual obligations: Age only: Necessary to verify eligibility for EPA enrollment

Consequences of not providing data: Registration failure. Sensitive data: Grants and benefits may be declined

Who can access the data: Internal staff of the Press Freedom Foundation, EU integrated communication services

Data retention period: 5 years; For sensitive data: Until its withdrawal.
